

Description:

This seminar is a basic review of heat, air and moisture transport mechanisms across the building enclosure and the design control strategies. The first section will discuss heat transport mechanisms and heat management. There are 3 main mechanisms of heat transport: conduction, convection and radiation. Heat flow by conduction (*through materials*) is discussed in the first section which includes a brief review of thermal insulation materials and energy code requirements for thermal insulation. Heat flow by convection (*through air currents*) is controlled with a *Continuous Air Barrier*. A summary review of the overall impact of air leakage on building enclosure performance and the importance of air leakage control is provided in the second section. Air leakage and Air Barriers are addressed in more details in other CES presentations by the same provider (Air Barrier-1 and Air Barrier-2). Heat flow by radiation (*through space*) is not discussed in this seminar and it is more important for fenestration than for the opaque envelope. The last section is a brief review of moisture sources in buildings, moisture transport mechanisms, and moisture control strategies. The building science principles behind the moisture management are briefly discussed. Moisture management principles are addressed in more details in other CES presentations by the same provider (Moisture 1 and Moisture 2).

3. Moisture transport mechanisms and moisture control strategies

Government vs. Commercial Construction Contracts & Specifications: Cross-Pollinating Best Practices

This is a summary of a learning session lead by Joseph Scarpa, Department of Defense and Elias Saltz, Conspectus at CONSTRUCT 2019. These notes are my understanding of what was presented.

Commercial work is subject to varying regulations that we are all familiar with. Government regulations seem onerous and scary but how do the two actually compare?

Government regulations actually centralize many requirements into single sources that can help eliminate conflicts. There are several large regulations that address broad areas of the contracting world.

The Federal Acquisition Regulations (FAR) address the contracting methods with one subpart specifically dedicated to construction. The Unified Design Criteria compiles into one place what, in the commercial sector, may come from each institution or not at all. The Unified Specifications give common specs to work from. Guess what? You may recognize the format as it is based on CSI's own Uniformat!

The government also has some resources that can also

make things easier. Did you know that there is a free program that will aid in writing specs (Specs Intact). Also, the Small Business Administration (SBA) can help the contracting officer find and qualify contractors.

There is, however, a confusing stack of legislation dictating procurement for government contracts - green products requirements, Buy America Act, Berry Amendment, Trade Agreements, National Defense Authorization Act, etc. You also need to be aware that some agencies are not subject to the unified requirements (VA, GSA) and some agencies will have their own requirements above the standards (Navy).

The takeaway is, while there are some things the commercial sector definitely does better, government contracting has its own strong points. With the increase in public private partnerships (PPPs), I would expect to see some merging of these requirements.




