

HIGH PERFORMANCE COMMERCIAL WALL SYSTEM DESIGN

AIA Program: HPCWALLS (1 LU/HSW) GBCI Program: 0920017160 (1 CE)

Description: This course defines the latest code and testing requirements for water, air and fire considerations in exterior wall assemblies. Participants will learn the various options for water and air control



while exploring various wall assembly designs. In addition, participants will be introduced to building science analysis tools to recognize the impact of various designs on longterm building performance.

He is certified with the Masonry Institute of Tennessee and Brick Institute of America as a certified masonry inspector and has worked on several projects with the Oak Ridge National Laboratories Buildings Technology Department; DIY; Charter Cable Home Improvement Series; HGTV; ZEBRAlliance and was instrumental in helping test three new product applications from the DuPont Building Innovations Team for the North American market. He has given over 1000 seminars to architects, code officials, builders, and other building professionals in the U.S. Darson is certified with architect, builder, and building codes organizations as an approved educational speaker in the area of Moisture Management. He is certified as a Home Energy Auditor and is a LEED Green Associate. He has been certified as a Construction Documents Technologist from the Construction Specification Institute.

DID YOU KNOW CDT IS NO LONGER A CERTIFICATE IT IS A CERTIFICATION!

The Construction Documents Technology (CDT®) designation is transitioning from a certificate to a certification!

Supporting professional success for AEC professionals is CSI's primary reason for being, and the CDT credential is an important professional accomplishment. CSI has embarked upon a strategy to transition the CDT to a certification. This transition has been in the works for several years, prompted by CSI volunteer leadership serving on the Certification Committee and the CSI Board of Directors.

Careful thought and planning has gone into this initiative to ensure that the CDT certification will be held up as a "gold" standard of certification. It is worth noting that while some perceive the CDT as a certification, it has not been in the past. The main changes to the program are adding modest prerequisites and a continuing education requirement.

While the change to the CDT took effect on July 1, 2018:

No action is required until 2021 besides earning your Learning Units in preparation for maintenance of your certification.

- For current CDT certificate holders, the credential is still valid. Log into your CSI account to view your Certification(s) and recertification date(s).
- Recertification of any CSI credential is fully voluntary.
 Maintenance of the CDT certification is only necessary if you wish to continue use of the CDT as a professional certification.
- Professionals holding the CCS and CCCA certifications are not required to maintain the CDT.
- · Retesting is not required as long as you meet requirements to recertify and maintain your CDT.

CDT Prerequisite Requirement:

High School diploma or equivalent. College-level coursework and/or two (2) years' experience in construction management is highly recommended

CDT Recertification Requirements (3-year cycle): Complete Recertification via CSI website

- Provide evidence of completion for 24 Learning Units of professional development
- Pay current recertification fee

To view your Recertification status, log in to the CSI website and navigate to the "My Certifications" page from the menu.


CSI certifications are valid for three years and expire on June 30 or December 31 of the third year, based on the date of the initial certification. CSI sends email reminders for Recertifications beginning 120 days prior to the deadline. If you have opted out of receiving CSI emails, it is your responsibility to monitor the due date for your Recertification(s).

To Recertify:

- Actively learn and earn at least 24 Learning Units (LUs) within the three years leading up to your recertification date.
- Log your qualifying 24 Learning Units (LUs) into your CSI account (membership is NOT required).
- · Complete the Recertification attestation.
- · Pay the recertification fee.




